**—PAYMENT OF CHARGES—**

The Carrier shall not deliver or relinquish possession of any property transported by it until all tariff rates and charges thereon have been paid except when arrangements have been made prior to or at the time the shipment is accepted for transportation. Nothing herein shall limit the right of the Carrier to require before the transportation is performed the prepayment in part or in full or a guarantee of the charges.

**—APPLICATION OF RATES—**

The hourly rates published herein for local moving shall apply to:

- (a) The job time required in removing goods and loading on vehicle at premises from which goods are moved, in transportation between premises, and in unloading and placing goods at premises to which the goods are moved; and
- (b) The minimum charge for local moving at hourly rates shall be the charge for two hours according to number of men employed on the job.
- (c) Travel time to and from Carrier's office or garage to Shipper's premises to Carrier's office or garage after completion of job.
- (d) Computation of charges for fractional parts of an hour: Charges for fractional parts of an hour shall be computed by adding one-quarter of the hourly charges for each fifteen minute period or fraction thereof.
- (e) Interest of 18% per year will be assessed on accounts remaining unpaid after 30 days.

**—ITEMS BLUEMOUND EXPRESS IS NOT RESPONSIBLE FOR—**

Household goods moved by the Carrier will be handled with utmost care. To provide proper service and protection to you, you are requested to report any complaints, in writing, to the driver at the completion of the move. If furniture is scratched, it will be professionally repaired—not replaced. We will not be responsible for mechanical malfunctions. Any irreplaceable items, or items of special or extraordinary value such as cutglass, crystal, paintings, antiques, cash, important documents, jewelry, etc. will be moved at Shipper's own risk.

The Carrier will take fragile items, however it will not be responsible for items not packed in boxes, such as glass, ceramics, lampshades, statuary, etc.

The Carrier will not be responsible for plants or damage to pressed wood or hardboard furniture. Carrier will not be responsible for any broken or misplaced items packed by Shipper.

Items not covered by insurance will be shipped at Shipper's own risk.

Shipper has the option to inspect the truck upon completion of the job to ensure all items have in fact been delivered by Carrier. Failure of Shipper to inspect truck upon completion of the job relieves Carrier of any further responsibility of such items.
